The Board of Supervisors of Clinton County, Iowa, met. Present were Supervisors Determann, Irwin and Srp. Minutes of the previous meeting were read and approved.

Coronavirus/COVID-19 update: County Community Health Manager Michelle Cullen reported 33 new cases were reported in the County since Thursday. Cullen said hospitalizations are as low as they have been since September. She said Mercy is only at one this week. The 14-day positivity rate is 9.6% and going down slowly. Cullen reported 3,737 vaccinations have been started and 1,547 have been completed. She said clinics fell behind this week due to delivery of vaccinations from the hub. She said they will work hard to catch up this week.
