The Board of Supervisors of Clinton County, Iowa, met. Present were Supervisors Irwin, Srp and George. Minutes of the previous meeting were read and approved.

RESOLUTION 2023-185

WHEREAS, the Board of Supervisors is a voting member of the Clinton County Emergency Management Commission but does not independently consider or appoint employees to the Clinton County Emergency Management Agency; and

WHEREAS, the Board of Supervisors has the administrative duty to authorize payroll for the County Auditor; now

THEREFORE BE IT RESOLVED by the Board of Supervisors of Clinton County, Iowa, that the County Auditor be and is hereby authorized to issue biweekly paychecks for the Clinton County Emergency Management Agency to Dannie E. Howard, as a temporary part-time Operations Officer. This will be in effect at an hourly wage of \$29.02. Starting date of employment with the Emergency Management Agency will be August 7, 2023.

County Attorney Mike Wolf recommended action be delayed on the Linn County juvenile services contract resolution as he would still like to research when the Scott County facility may open. He said the County may want to shorten the Linn County contract depending on Scott County availability.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker said his office is getting ready for the City/School Election in November. He said some candidates may already be circulating petitions to get their names on the ballot. He said those nomination petitions can't be filed until August 28 and due date is September 21. He encouraged anyone interested in working the election or running in the election to visit the County election website.

Supervisor Srp said he will be attending the Conservation Foundation annual meeting tonight instead of the public hearing. He said he will listen to the recording of the public hearing before voting on the proposed ordinance.

County Treasurer Dustin Johnson said they are prepping tax bills to go out and some residents have already found them online.

County Sheriff's Office contract: Chairman Irwin said they received a letter about the contract and a negotiating session will be scheduled.

Chairman Irwin called a public hearing to order to solicit comments on a proposed map amendment to the County Zoning Ordinance of a change from A-1 to M-1 for property in Orange Township.

Proof of publication was presented, accepted and returned for filing.

Present were Supervisors Srp and George, County Auditor Eric Van Lancker, County Planning and Zoning Director Thomas Barnes, public and media.

Barnes reviewed the proposed change for River Valley Coop to operate a 30,000 gallon LP tank. He said there have not been comments filed by neighbors.

No comments were submitted or made during the public hearing.

6:03 P.M. Public Hearing – Rezoning Application Request

Chairman Irwin called a public hearing to order to solicit comments on a proposed map amendment to the County Zoning Ordinance of a change from A-1 to Renewable Energy Overlay (RE).

Proof of publication was presented, accepted and returned for filing.

Present were Supervisor George, County Auditor Eric Van Lancker, County Planning and Zoning Director Thomas Barnes, public and media.

Proof of publication was presented, accepted and returned for filing.

Barnes reviewed the proposed change.

Irwin explained the Board of Supervisors will have a meeting Friday morning at 10:30 a.m. to consider the rezoning requests.

Sam O'Keefe, Hawkeye Solar representative, provided a presentation about the proposed project. He said it will generate 120 megawatts of additional capacity with a 70 megawatt battery capacity. He said the acreage is more than 1,300 acres, but the actual usage of the project will occupy just more than 650 acres. He pointed out that these panels will be made in America. He said that is an update from the first project and his company is excited about that. He said planted around the solar panels is native grasses which will allow for sheep grazing and bee apiaries. O'Keefe reviewed the six-acre footprint that will be used for the battery storage. He said it is being done to help mediate the feeding of power into the grid to match supply and demand when it is heavier outside of the peak production hours for solar. Paul Hayes, a fire protection engineer and subject expert on batteries with Hiller, said he has been involved in writing standards and best practices for battery storage safety. He said this is technology being used around the nation and isn't new and will meet all the required codes. He said emergency response plans and training will be provided before the system goes online. O'Keefe concluded the presentation by pointing out that the Hawkeye II project meets or exceeds all of the same requirements of the county-approved Hawkeye I project.

Mandy Menard, County resident, said she was concerned about the disruption of wildlife. She has trumpeters in her area and they can be in danger from electricity and electromagnetic radiation. She said the radiation could reduce the

health and life of people as some people are sensitive to that radiation. She is also concerned about property values dropping. She is afraid the views will be harmed. She is also concerned about giving up prime farmland for this project. She is also concerned about batteries because there are stories of those blowing up and they are a fire hazard. Dave Whitman, County resident, asked about the cost of a solar panel. He said he needs that for his insurance company. O'Keefe said Whitman does not need to worry about liability. Whitman said that's not what his insurance company told him. He is concerned if a piece of his equipment catches fire and spreads to a panel. O'Keefe said it is about \$300 a panel. Whitman said the County is going to be in charge of the cleanup and said the attorneys agreed with him. Irwin said he has reached out to insurance companies in the area and not one has said liability insurance is needed. Whitman said his agent said it is required. Irwin said the County has an attorney representing them in this matter. Whitman said farmers get assessed for any buildings they build. He asked why doesn't solar farms get the same consideration? Irwin said taxation for a utility is set by the State of Iowa and the Iowa Utilities Board. Irwin said the County is struggling with the fact that if this were a wind project the taxation through the energy production would be much more than solar. But the State sets those rates for utilities and the County doesn't have a say. Whitman said the Board could vote no on the project. Whitman said there should be containment on each battery because they will go bad and won't be replaced and it can catch any byproduct from its deterioration. O'Keefe said each battery is in a containment casement. Hayes said there is very little liquid in the batteries. He said it would be ounces. He said if it burns, most liquids would be burned off. He said if they burn, they let them burn out without water on them and that keeps contamination to a minimum. Whitman asked about transmittal lines. Irwin said they will have easements like any utility company. O'Keefe said transmission lines are all contained within the leased land.

Brian Robinson, County resident, asked why this issue is not voted on. Van Lancker said there are a list of public measures allowed by the State of Iowa that can be voted on and this issue is not included. Supervisor George said landowners have all voluntarily agreed to these deals. Robinson said its right out his front yard and he doesn't get a vote on it. He said the Board is not representing all people fairly. He said it will look like a prison fence outside his front door.

Kay Pence said when she built her house her neighbor lost their view and the neighbor could have just as easily purchased that land. She said this land is not lost forever and is good for pollinators and is good for jobs in the community. She said if a factory was built there the land would be lost forever.

Bill Gearhart, former president of the Iowa State Building Construction Trades Council, said this project will produce good jobs with good pay and benefits. He said these are not temporary jobs. He said to a construction worker, this is part of that worker's career. He said this is also about property rights as all the owners have voluntarily signed a lease.

O'Keefe said at the peak of the project there will be 300 good jobs. He added most of the jobs are during the construction and then after there is not a lot of activity and there will be three to five full-time jobs. He said construction may take 12-18 months. He said local labor will be used but will be based on availability. He said they will conduct local job fairs as part of the zoning approval process.

John Maynard, County resident, asked where the tax dollars would come from locally and the benefit to the community. Irwin said he visited two solar sites in central Illinois. He said labor stayed in hotels. He spoke to neighbors around those sites and they reported they had a good experience with the project. O'Keefe said they have seen around 78% local labor in their projects in Illinois and Michigan. He said those laborers live and spend their money in the community while the project is being built. He said the County is not losing any property tax from this project. He said the projects are expected to start construction near the end of 2024.

Whitman said this will create around five jobs, but asked what about the farmers that may be put out of business. He also had concerns about the batteries and they shouldn't be put there unless there is a recycling plan for those. He said this company could be sold many times during the time this project covers. O'Keefe said the County has put a lot of thought into the decommissioning plan that includes funding of around \$6 million. He said the decommissioning plan will be updated every five years to address technological changes. Hayes said this is still a fairly new industry and there are other industries that are cropping up to address battery recycling.

Chris Berg spoke in support of the rezoning. She said the land has been in her family for generations. Her family believes this will be good for the land to rest and will be put back into crop production and believes this is a good project for the community.

Ryan Drew, operating engineers' business representative, said Ranger Power's commitment to local labor is good because it can be a steppingstone for a career that can be promoted to high school students.

Ann Haring said the Supervisors are elected and they are conservative elected officials and said the majority of the people who contacted the Supervisors were against the project. She said the Supervisors said most of them are against the project. She encouraged the Supervisors if they wanted to sleep at night they should consider the people who elected them to office. She said she has family that can benefit from this project but is still against the project. She said if this project does not fit into the master plan and a majority of residents have asked not to approve this. Irwin said he believes this issue did have an impact on his re-election. But overall he represents the entire County

and most of the negativity of the project is in this area. He said he voted to approve the first project and he still has questions about the battery. But he believes the impact with renewable energy even though it exists with subsidies, is important for economic impact. He said companies are looking for more renewable energy. He said a company reached out to Clinton to ask for a million kilowatts of renewable energy and that needs to be considered. Supervisor George said she appreciates everyone's opinion and doesn't take any of this lightly. George said I'm going to always do what I believe in and if I don't have this job next November then so be it.

Maynard asked if Clinton County is going to get any of the energy produced here. Irwin said the power generated is part of the larger grid of states in the Midwest. He said it would be difficult to say it will specifically stay in the County. O'Keefe said the project runs like any power plant in the system. It's produced locally and then interconnected to the system which provides power to the region. O'Keefe said companies are looking for more renewable energy and that's why these projects are becoming more common.

Chris Haring, County resident, said Alliant Energy is going to renewable because Joe Biden said we are going to renewable energy. He said natural gas plants can run for years. He said he is an industrial firefighter and the firefighters will put water on the fire of a battery. He said the winds are out of the west and he knows what will happen in the City of Grand Mound. He said it will be the first town evacuated. He said if Lyondell has a fire, they will evacuate Camanche and Clinton.

O'Keefe addressed questions about the wind capacity for the solar panels. He said he answered that at the last meeting and doesn't have an update from that meeting.

Larry Banowetz, Grand Mound, asked if animals will be grazing who will be responsible for keeping up the fences. O'Keefe said that will be the responsibility of the project.

Whitman said he will have deer damage after the project builds the high fences. He said there may be more damage to cars also. Bob McGee, attorney representing the County, said he doesn't see how liability could be assigned to something like that.

Mandy Maynard said the County should possibly see how the first project goes before the second one is approved. She believes not everyone in the County knows about the project.
