I. Call Meeting To Order -

MENTAL HEALTH – Group met on February 10th and discussed 48 hour emergency hold procedures, 229 recommendations from Dr. and forms. Also discussed peer support training.

III. Financial Report – Sheriff Lincoln

Balance as of January 31, 2014 was \$54,614.80 and then on February 12, 2014 we received an invoice from Shive Hattery for 98% of the Needs Assessment which was \$29,910.59 - county portion (\$14,741.65 Communications and \$8,759.53 Clinton PD) which leaves us with a balance of \$24,704.21.

IV. Jail Needs Assessment

Project Update: On February 7th Craig Eberhart, Sheriff Lincoln and Brian McKenrick met with Shive Hattery to go over six years of data supplied to them, which is being used to anticipate future costs of staffing, food and jail operational costs. Predictions are based on the data provided as well as



growth of our community, population, etc. Final report and presentation will be available sometime in April which will include our next steps.

V. Coordinator Position

Application deadline was February 14, 2014 and we have 16 applicants. A majority of the applicants were local with one from Texas and one from Washington DC. Sheriff Lincoln, Brian Schmidt, Craig Eberhart went through the applications with the HR Manager and narrowed them down to five (5). The next step is going to include applicants submitting a video of themselves answer five (5) or so questions, once these are sent out applicants will have a two (2) week deadline. Once the videos have been received interviews will be set up. Interview committee will include: Becky Eskildsen, Craig Eberhart, Mike Wolf, Sheriff Lincoln, Norlin Mommsen and Lynn Tibbetts.
