DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reminded the Board of its tax levy public hearing tomorrow at 10 a.m.

County Treasurer Dustin Johnson reported April 1 is the last business day of March for the Treasurer's Office due to offices being closed on Friday. DOT investigator hosted a training on how to spot suspicious car titles.

DISCUSSION WITH POSSIBLE ACTION

Medical Examiner Investigator/Transporter Discussion

The following resolution was presented and on motion approved:

RESOLUTION 2024-83

WHEREAS, the Medical Examiner of Clinton County has taken a temporary leave of absence; and

WHEREAS, Medical Examiner Services must be covered and the Scott County Medical Examiner is willing to temporarily cover Medical Examiner Services; and

WHEREAS, the Clinton County Board of Supervisors has determined that this is the best course of action for temporary services for Clinton County; now

THEREFORE BE IT RESOLVED by the Board of Supervisors of Clinton County, Iowa, that the Board Chairman be authorized to sign an agreement extension with Scott County for temporary Medical Examiner Services with an end date of December 31, 2024.

Communication Commissioner Update: Chairman Irwin said Communications Director Eric Dau is resigning his position. Sheriff Bill Greenwalt, Chairman of County Communications Commission, said there were tough decisions to make in that meeting involving a temporary position. He said the commission voted to temporarily appoint Lt. Scott Reyhons in the Sheriff's Office to oversee the Communications Center until a new solution for the vacancy is addressed. Dau thanked the County for allowing him to serve in the Communications Center. Dau said for the success of the next person, the leadership of the organization should be reviewed as there are too many people to answer to.

Review of the County Wind Energy Ordinance: Irwin said this discussion came about due to a recent Board of Adjustment meeting that turned into a discussion of possible wind turbine development in the north central portion of Clinton County. County P&Z Director Thomas Barnes said the wind turbine section of the ordinance was updated in 2008. He said there are no limits on turbine height, but it does include setbacks. Srp said a lot has changed in the industry since 2008 and this section likely should be updated. George asked for this to be on the agenda because of discussions she's had with other county supervisors from across the state. Barnes said he has had discussions with other counties and Clinton County's ordinance appears to be pretty thorough. He said other counties look toward our ordinance for guidance. Irwin said the first solar operation approved in Clinton County took nine months to get in place. He said there is time to review the ordinances and make changes in the ordinance as needed. Srp said timelines need to be set for this review and parameters on who is working on the updates. Irwin said the County Attorney said we cannot do an indefinite moratorium and that a start date should be set, and it shouldn't exceed 90 days. Srp said there will be several opportunities for the public to share their thoughts about the ordinances and any further projects. Mary Bartel owns farms in Clinton and Jackson counties. She said it's very hard to find positive comments about the betterment of life from these wind farms. She asked the Board to consider public safety as well as the decommissioning of the turbines. Bartels also has concerns about the County roads that would be used for the operations. Srp said he appreciates the questions, and it is difficult to answer until the actual permit is filed. Bartels thanked the Board for reviewing the ordinance and talking with other counties about their experiences. Mike Carberry, Bright Future Iowa, said the County board has been thoughtful about how to proceed with these matters and their decommissioning plans have been solid. He recommends that counties find ordinances from other counties that are working well and put them in their ordinances with their local spin. Carberry said to watch out of those ordinances as some are written to not include wind turbines in their county. Irwin said the Board worked over the first solar project pretty hard and came out with the best result they could. Srp would like Barnes to point out areas to the Board where things should be considered in the ordinance. Landon and Alyssa Rorah, are farmers and he is on the volunteer fire department in Delmar. They thanked the Board for their consideration of having meetings in the affected area. He is concerned about landowners' rights near these projects due to the noise and vibration. He said they live in the county for its natural sounds and not a constant noise and vibration. He is also concerned with turbines affecting weather radars for public safety. He said there is also an effect on livestock due to the constant noise and vibration. They also raised concerns about the bat population and location of the proposed operation near the Maquoketa Caves. Thomas Bean, Iowa Land and Liberty Coalition, offered resources for industry standards that can be used when the Board reviews its ordinances. Lee Good, landowner near the proposed tower, said the population may not be dense there, but the people who live there should still be considered. Irwin mentioned he would discuss what would be needed for a moratorium with the County Attorney

Annual Audit Firm Recommendation: Van Lancker said RFPs were sent to 10 firms and three submitted proposals. He said the committee reviewed and discussed the submissions and recommends the Board engages with Eide Bailly LLP for auditing services.

Van Lancker reviewed what other partners in the Peanut Butter Student Loan administration are doing for their employees. Srp said if it is being used as retention is there a retention problem in the County to address. Johnson said this would be outside the original scope of the project and significant change to the expenditure line and it may not be fair to the positions that don't require a college or two-year degree or more.
