GENERAL PUBLIC

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reminded the Board that it will meet next week on Tuesday, March 5, and that meeting will include the public hearing for the proposed FY20 County budget. He added the City of Calamus Special Election to fill a vacancy on its city council is tomorrow and the canvass will be at 9 a.m. on March 5. He also reminded the Board of the Conference Board meeting scheduled for Tuesday.

County Engineer Todd Kinney reviewed a letter from the City of Maquoketa asking if the Board would allow the County Engineer to sit in on the selection committee for a grant it received to hire a consultant. He said he is willing to assist. It was generally agreed Kinney would be able to assist the city. Kinney said he'll be meeting soon with his roads foreman to devise a plan to address road issues that will likely appear as spring starts.

Chairman Srp said negotiations with the Sheriff's Office union are scheduled for Thursday and he would not be able to attend. Vice Chairman Determann said he will be the lead for the supervisors.

DISCUSSION WITH POSSIBLE ACTION

Supervisor committee assignments: Srp said he started to experience too many conflicts with his assignments and would like Supervisor Irwin to represent the County on the Mental Health Region board. Irwin said he was agreeable to serve on that board starting with the February 25, 2019, meeting in Davenport.

9:46 A.M. Clinton Regional Development Corporation (CRDC) Quarterly Update

CRDC President/CEO Erin Cole reported she has been in her position for six months now. She said they have had an increase in inquiries of businesses looking at the region including some local companies considering expansion. She said some have a potential to hire up to 120 employees. Cole said her organization is considering building a spec building at the railpark as some companies are looking for building space that currently exists. She said the CRDC website will be updated to include more user friendly information for those looking at the region. She said the water company is moving ahead with plans to provide water and a grading study was also recently completed at the railpark. Cole said signage to the park has been installed for visitors to better locate the railpark. Andy Sokolovich with the CRDC spoke about retention and growth of business in the region. Sokolovich said no other county in Iowa is experiencing the success Clinton County has recorded for the Home Base Iowa program.
