Aaron Brewer, Clinton, is interested in purchasing a property in Clinton. He said it is an old church property and he would like to rehab it for a community center and small food service business. He said the property has been empty for almost 10 years since a fire damaged the church. He's working with the current owner in Nebraska. He is petitioning that the back taxes be forgiven. Brewer said the property would need to be rezoned to commercial and it is on the border of a commercially zoned area. He said he is working with the city and doesn't believe the rezoning will be an issue. Chairperson Hamerlinck said this is an instance of demolition by neglect which is used by companies and he does not like this practice as it takes advantage of local governments. He will support what Brewer is trying to do. He will work with Brewer and the County Treasurer to bring a resolution to the Board.

Ray Ackerman, Compassionate Care and from DeWitt, mentioned his contract with the County has expired. He thanked the County for allowing his company to provide medical examiner transportation during the last 10 years and looks forward to offering the service in the future.
