# III. Budget Proposal

Funds requested total was \$94,280 which is a decrease of \$2,057. This would include removing needs assessment funds, and increases to salary line, telephone services and a decrease in education/training and purchase of equipment.

Jail layout and design will depend on site location whether its green field or current location with projections, etc. working for the next 20 years. Currently they are working on manpower costs and green space will include space for long term building a new courthouse.
