## V. Jail Site Selection Group

Site selection committee last met on April 4<sup>th</sup>. Sheriff Lincoln gave an overview of the Shive Hattery Report of Findings of the four final sites selected. Criteria for each site was



based on ten different areas of importance, which included site, parking, identity, site are, neighbor. The four sites are:

1.	Existing Law center	\$21,204,000	94pts
	19 <sup>th</sup> avenue NW	\$21,465,750	74pts
3.	SW Millcreek/13 <sup>th</sup> Avenue N	\$21,617,500	62pts
4.	SW/SE Millcreek/Hartsmill Road	\$21,691,500	71pts

The subcommittee voted to recommend Option 1 the current site. Go to <u>www.clintoncounty-ia.gov</u> to see the full report. Expenses more offsite due to sewer, water, and utilities already exist, staffing cost, we own the property already. Issues to consider included river levee being certified and possible barriers, also alternative could be raising up facility a few feet. The current rate of inflation is 4.5 - 5% for this area. The longer we wait the more it will cost. This would be a two year construction project working best at no rush.
