DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

Supervisor Srp said there is a phone call tomorrow morning concerning a railroad bridge over the Wapsi River. He said they are also working with Senator Grassley's office about federal payments to the Seventh Judicial District. Supervisor Irwin said he and Sheriff Bill Greenwalt met with a firm last week to provide crisis intervention training for law enforcement. Irwin and Greenwalt reported the firm was impressed with where the local law enforcement is currently with crisis intervention. Irwin said the Board should plan its next meeting about the solar field applications. Determann suggested placing the topic on the next meeting agenda to prepare for a future meeting. Greenwalt said Saturday from 10 am to 2 pm the Law Center is hosting a medication and vape take back event. Greenwalt said this program is traditionally very successful. Kristin Huisenga, Clinton Substance Abuse Council, said Clinton will be the first community to offer the vape take back program. Huisenga said if people want to drop off vapes, she asked that they remove the battery from the device. Greenwalt said the Clinton County Resource Center was awarded the Byrne-JAG grant. He said it wasn't the full amount asked for, but it will help build the Resource Center for the future. He said they can apply for the grant for three more years.

County Treasurer Dustin Johnson reported the notices being sent out sooner than the County traditionally does has been successful.

Naeve Family Beef USDA Grant Application: Irwin said he was contacted by a representative of the company asking the Board to submit a letter of support. He said it does not include financial support.
