I Smile program: Scott County Health Department has submitted a proposal to take over the dental program for our region but it has not been awarded by the state yet.

New business/Community Input: Gwen reported that there will be a community baby shower/toddler fest on September 24, to be held at the Clinton County fairgrounds in DeWitt. Peggy reported the AECIABA conference is scheduled for November 10 in Des Moines.
