AN ORDINANCE AMENDING THE MAP OF THE CLINTON COUNTY ZONING ORDINANCE RELATIVE TO THE ZONING DESIGNATION OF CERTAIN PROPERTY LOCATED IN SECTION 21, TOWNSHIP 81 NORTH, RANGE 6 EAST OF THE 5TH P.M. IN CLINTON COUNTY, IOWA

BE IT ENACTED BY THE CLINTON COUNTY BOARD OF SUPERVISORS:

Section 1: The zoning district boundaries of the County of Clinton, Iowa, are herewith changed so as to provide for the change of the following described property: A portion of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of section 21, township 81 north, range 6, east of the 5th P.M. Clinton County, Iowa, described as follows:

within the A-1 (Prime Agricultural) District of Clinton County, Iowa to AR-1 (Agricultural Recreational).

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reported he took part in the Clinton Community School District reunification drill last week. He said it was good to see it practiced by a local school and a lot was learned during the drill. He said the school drilled the reunification model it learned from the County-sponsored training.

Supervisor Srp said Conservation is starting to do some preparations for the predicted Mississippi River flooding.

Chairman Irwin said he and some city officials received an update on Friday on the work taking place on the former Ashford property. He said he was very pleased with the progress that is being made. He said there are 120 students expected over three weeks this summer for summer activities.

County Treasurer Dustin Johnson said property tax delinquent notices have been sent out early again this year since it was successful last year. He said there is about \$2.2 million outstanding in property tax that is due. He added they are working on a FAQ sheet similar to what Scott County provides with their tax bills.

County Facilities Director Corey Johnson said the HVAC balancing project in the Administration Building will begin the week of May 8 and will last a week. He added the electrical engineer has the plans for the generator upgrade and he will review them with Irwin to get the bid process started.

DISCUSSION WITH POSSIBLE ACTION

Area Substance Abuse Council Grant Update & Request: Candace Seitz of ASAC, provided an update on a program funded through a JAG grant through the County. She said ASAC has the opportunity to apply for another JAG grant through Clinton County. She reviewed the program and asked if the County would again be interested in supporting the grant.

MOTION by Supervisor Srp to support funding for the ASAC and Clinton County Partnership for a substance abuse program.

Opioid Settlement Funding Discussion: Irwin said he reached out after Van Lancker sent an email inquiring about interest in how to spend the settlement funds. Irwin asked who the County would be willing to fund to attend this conference in Des Moines in May. Irwin said the county could fund County employees to go and an outside agency representative like someone from CSAC. Sheriff Greenwalt said the names he’s heard the County potentially sending would be a good group to bring back the information for the County and his staff doesn’t need to go. Irwin said he will follow up with the County Attorney about sending a representative from his office.
