DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker asked where the Board would like to continue to meet. He said IT has reported that the large conference room in the Law Center is now set up for Zoom so that location could be an option. He asked about the Memorial Day holiday week and the Board decided it would not meet that week. Van Lancker also reported they learned late last week that the third-year funding through the Byrne JAG for the Clinton County Resource Center was not awarded. He said he, Chairman Irwin and Sheriff Bill Greenwalt will meet tomorrow morning with officials from the Seventh Judicial District to discuss the future funding for the program.

Supervisor Srp said interviews for the maintenance department manager position were last week and a candidate was identified. He said he is meeting with Human Resources and Van Lancker to come up with an offer.

Chairman Irwin said the meeting with the Clinton County Firefighters Association went well. He thanked Kehly Kennedy Ivory for assisting with getting signage for the Administration Building project.

Supervisor George said the June statewide gaming commission meeting will be conducted in Clinton.

County Sheriff Greenwalt reported the Sheriff's Office received a going above and beyond award from CSAC during its annual meeting. He said there were a couple of accidents that occurred in the County involving a UTV and another with a golf cart.

County Treasurer Dustin Johnson reported his office is moved to the Board Room as part of the Administration Building project and thanked IT for getting the temporary office set up. They met with Clinton National Bank and learned where they could enhance security for the County and they are testing it now and will share with the Auditor's Office as it gets ironed out. The tax sale list will be published soon, and it is about 1,100 parcels which is down by about 600 compared to last year. He said the new cross titling opportunity could result in an increase of almost \$300,000 to the County.

Planning and Zoning Director Thomas Barnes said the County received a notice for a master matrix review. He said the timeline is very tight. He said the Board must host a public hearing. The Board decided to have a brief meeting Thursday to help meet the timeline.

DISCUSSION WITH POSSIBLE ACTION

County Sheriff's Office Patrol Contracts with Cities in the County: Sheriff Greenwalt reviewed the new contracts. He said he has visited the cities about any increases they may experience due to wages and vehicle replacement.

MOTION by Supervisor George to authorize the Sheriff to sign the agreements for law enforcement patrol for various cities in the County.

County Administration Building Project Update: Van Lancker said mobilization was to begin today. He said the north door to the building has been opened for visitors to enter the building. He said he did email the Administration Building tenants this morning. He said the County has yet to receive the window phase schedule. Irwin said there has been a change in the masonry plan which will save the County \$47,190. Van Lancker said he has not received any interest in the project manager temporary position. Srp said as the Board moves quickly to fill the maintenance manager position, a representative of the Board should meet with that person about their comfort level to oversee the project. HR Director Alexandria Ellison said her office has not received any interest in the second temporary maintenance position.
