BE IT RESOLVED by the Board of Supervisors of Clinton County, Iowa, that the amounts as shown, published, and approved in the County Budget for fiscal year 2024/2025 on April 22, 2024, be and are hereby apportioned for fiscal year 2024/2025 from the various funds of the County to the several offices and departments of County Government for the purpose set out in detail and on file in the office of the County Auditor.

RESOLUTION 2024-176

WHEREAS, it is desired to authorize the Auditor to periodically transfer sums from the General Basic and Rural Services funds to the Secondary Road Fund during the 2024/2025 budget year; and

WHEREAS, said transfers must be in accordance with section 331.432, Code of Iowa,

Section 1. The total maximum transfer from the General Basic Fund to the Secondary Road Fund for the fiscal year beginning July 1, 2024, shall not exceed the sum of \$316,412; and the maximum transfer from the Rural Services Fund to the Secondary Road Fund for the fiscal year beginning July 1, 2024, shall not exceed the sum of \$1,816,711.

Section 2. Within three days of being notified of the apportionment of current property taxes, state replacements against levied property taxes, mobile home taxes or military service tax credit replacements to the General Basic or Rural Services Funds, the Auditor shall order a transfer from said fund to the Secondary Road Fund.

Section 3. The amount of the transfer required by Section 2 shall be equal to the apportionment made under Section 2 to the General Basic or Rural Services Fund, respectively, multiplied by the ratio of said fund's total maximum transfer to the Secondary Road Fund, to the sum of mobile home taxes and total military service tax credit replacements.

Section 4. Notwithstanding the provisions of Section 2 and 3 of this resolution, total transfers to the Secondary Road Fund shall not exceed the amounts specified in Section 1.

Section 5. Notwithstanding the provisions of Section 2 and 3 the amount of any transfer shall not exceed available fund balances in the transferring fund.

Section 6. The Auditor is directed to correct his books when said operating transfers are made and to notify the Treasurer and County Engineer of the amounts of said transfers.

THEREFORE BE IT RESOLVED by the Board of Supervisors of Clinton County, Iowa, that it authorizes periodic transfer of funds to the Secondary Road Fund for fiscal year 2025.

10:00 A.M. Ports of Eastern Iowa Authority Update

Robert Sinkler said they started in 2019 to form some port authorities on the Illinois waterway and on the Mississippi. He said they started this effort to get on the map to attract infrastructure funding. He reviewed the steps to create a port authority through Code of Iowa Chapter 28J. Sinkler said the plan also includes developing a regional economic development collaboration. He said they want to follow the same model as other port authorities that have no budget and don't receive funds from the local governments. He said they want to get the port in place and then funding comes in from the federal government for infrastructure investment. County Attorney Mike Wolf reviewed the resolution and the by-laws. He said he is satisfied with what is available and could offer more toward the by-laws. He said ECIA would be a benefit for the more regional matters. Wolf said Clinton County would not need to wait on other counties to approve a resolution. George said she would support moving ahead with a resolution and work on the by-laws. Wolf said he has been working with county attorneys in neighboring counties. He said Scott County is still assessing the proposal. Wolf said a governance board would be created and then they would retain a consultant for the administration. He said there are a lot of decisions to be made for the by-laws, but it wouldn't be too complicated. Srp said this sounds like a good opportunity, but Scott County must be included. Sinkler said Clinton, Scott and Muscatine are the major counties to reach the tonnage thresholds needed for the opportunities the authority could provide. A resolution to establish a port authority will be presented to the Boad next week.
