RESOLUTION TO APPROVE STOP SIGN INSTALLATIONS AT THE INTERSECTIONS OF 234TH STREET AND 282ND AVENUE AND 234TH STREET AND 284TH AVE

WHEREAS, the Clinton County Board of Supervisors is empowered under authority of Section 321.345 of the Iowa Code to designate any intersection as a STOP intersection and erect like signs at one or more entrances to such intersections, and

WHEREAS, the intersections of 234th Street and 282nd Avenue and 234th Street and 284th Ave (8th Avenue) are deemed to warrant a STOP signs. Because 234th Street is considered a through street, and it has a higher daily traffic count then 282nd Avenue and 284th Ave (8th Avenue), the traffic on 282nd Avenue and 284th Avenue (8th Avenue) should be forced to stop when entering onto 234th Street; now

THEREFORE BE IT RESOLVED by the Clinton County Board of Supervisors concurs with the County Engineer's recommendation that a stop signs be placed at the intersections described below and are declared valid, legal, and enforceable for the safety and welfare of the traveling public:

- 1. Stop Sign shall be placed on 282nd Avenue to stop northbound traffic at the intersection of 234th Street and 282nd Avenue.
- 2. Stop Sign shall be placed on 284th Avenue (8th Avenue) to stop northbound traffic at the intersection of 234th Street and 284th Avenue (8th Avenue).
