DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

Clinton County Auditor Eric Van Lancker said the Board is scheduled to meet November 25 and December 2. However, December 2 may be optional due to the quick turnaround for agenda items and he said it may be helpful to keep it open in case it is needed for the recount.

Chairman Irwin said the Workforce Commission is working toward replacing their fiscal agent. He said December 4 is their next scheduled discussion for the wind turbine ordinance.

County Treasurer Dustin Johnson submitted the fiscal year 2024 treasurer's report. He said they have also reached a settlement on Nevada Rail property tax. They are interviewing for the new clerk position this week.

DISCUSSION WITH POSSIBLE ACTION

Recount Request – US Representative IA District 1: Van Lancker said the Board of Supervisors by way of the Code of Iowa must take action to order the recount requested by Christina Bohannan, candidate for the seat. He said this allows the County Auditor to cut the seals on the boxes that hold the voted ballots.

The following resolution was presented and on motion approved:

RESOLUTION 2024-304

WHEREAS, the Clinton County Auditor's office administered the General Election of November 5, 2024, which included precincts in the United States Representative District 1; and

WHEREAS, the Clinton County Board of Supervisors on November 13, 2024, canvassed and certified the results of said election per the Code of Iowa; and

WHEREAS, Christina Bohannan, candidate for United States Representative District 1, properly filed a request for a recount of votes in United States Representative District 1 precincts in Clinton County as prescribed by Code of Iowa 850 48:

THEREFORE BE IT RESOLVED by the Clinton County Board of Supervisors that a recount of said precincts be ordered and that the County Auditor and Commissioner of Elections be authorized to conduct said recount as prescribed by the Code of Iowa.

County Fiscal Year 2026 Budget Planning: County Budget Director Nicholas Manrique asked the Board when it would like to send out budget worksheets and what direction they would like to provide to County offices for their budgets. Irwin said he would like to request another 10% reduction. Srp said for many of those departments their costs are going up and the 10% cut is becoming more difficult. He said even if they got 10% he's not sure that will still get the budgets where they need to be. Manrique said valuation is pretty flat with maybe a half percent growth. He said that does not include utilities nor rollback.

County Administration Building Project Update: Van Lancker and Irwin reported the windows in the cafeteria are complete. They said window work on the north side of the building begins tomorrow because rain has delayed it by a day. After the north end is complete, they will move to the front entry, the boardroom windows and then the north entrance doors.
