# RESOLUTION 2024-321

WHEREAS, the Clinton County Board of Supervisors shall place a moratorium on applications for Meteorological Towers (MET Towers), Sodar equipment, and any other equipment related to the development of utility-scale wind turbines, and

WHEREAS, the moratorium shall be repealed automatically on March 31, 2025, unless extended before that date by resolution of the Board of Supervisors,

NOW, THEREFORE BE IT RESOLVED by the Clinton County Board of Supervisors that the moratorium on applications for MET towers, Sodar equipment, and any other equipment related to the development of utility-scale wind turbines be in effect until March 31, 2025.

# DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Treasurer Dustin Johnson shared that across county titling starts January 1 and title transfers, liens and registration fees will increase. He said he is anticipating more dealers coming to Clinton County for service.

Supervisor Srp said he has a Conservation board meeting tomorrow night. He wanted to wish everyone a happy and safe holiday season. He added that he understands that with the 7th Judicial District Department of Corrections, Waylon Mccullough has resigned and at the meeting he attended, they discussed the process for filling of the position. Chairman Irwin said he attended the Secondary Roads annual gathering, with several retirees attending. He said he also attended the swearing in ceremony for the County Auditor and County Sheriff and the groundbreaking ceremony for the YWCA supportive housing facility last week. He talked about the changes in the Mental Health region, when Iowa Primary Care Association oversees the behavioral health facilities as of July 1, 2025, and he will provide another update as his next meeting as we don't know the next steps are going to be right now. Irwin also wished everyone a Merry Christmas and Happy New Year.

Sheriff Greenwalt wanted to thank his staff and all involved with the critical issue last week.

Supervisor George said she has a government committee meeting tomorrow at Grow Clinton. She also will be attending a CCDA meeting and an expansion meeting with the City of Clinton. She wished everyone a Merry Christmas and reminded them to be safe.

County HR Director Ally Weller reminded everyone of the county building closures on December 24 & 25, 2024 and January 1, 2025.

Emergency Management Director Chance Kness wanted to make sure everyone is aware that the Emergency Management Commission decided to end the use of the outdoor warning sirens in some areas of the county at the end of the year. The commission has directed him to go out for proposals for decommissioning of the sirens which the board will need to review.

Veterans Affairs Director John Bray shared an update on the Operation Holiday Cheer event for the veterans to be held on December 27.

# DISCUSSION WITH POSSIBLE ACTION

County wind ordinance revision consideration next steps: Supervisor George shared her discussion with County Attorney Mike Wolf and Bob McGee about how the county should move forward. She said will set up a meeting with Zoning Director Thomas Barnes and Wolf to share her perspective on the changes she feels should be in the ordinances. She said a meeting with the Planning and Zoning Commission should be scheduled toward the end of January or early February to make decisions on getting the ordinances updated. Barnes said he will start working on rewriting and revising the county ordinances.

Preview of the 2025 Iowa Legislative session with area representatives: State Representatives Tom Determann and Norlin Mommsen provided an update on the upcoming sessions and priorities.

Funding request by the Mississippi Valley Workforce Development Board to support SkillUp Mississippi Valley: HR Director Weller shared the services SkillUp provides as an on-line learning management system. SkillUp is a free platform for individuals who want to improve their skills in various occupations. This free service is available to all Clinton County residents. Mississippi Valley Workforce Development is requesting funding support from Clinton County. Irwin said he wanted to share the information with the rest of the Board and would like to have another discussion closer to budget planning.

Posting for a special deputy position in the County Sheriff's Office: Sheriff Greenwalt explained his request to change an open bailiff position to a special deputy position which would allow the employee to be able to do additional functions that the bailiff position is not able to do under code. Supervisor Srp questioned the change in the position and the additional expense that is caused by a mandate for the judicial district from the State level. Greenwalt explained the need to fill the position. Irwin said he understands there is an additional cost for a special deputy compared to a bailiff. He said that we haven't had anybody at the Administration Building because of the construction going on. He said in favor of moving forward with the posting of the position because he feels we have a need for the position but he is still concerned about the budget.

MOTION by Supervisor George to allow HR to post and the Sheriff to proceed will filling the Special Deputy position in the Sheriff's Office.

County Administration Building project update: Irwin reported that front entry doors will be received on Thursday and installed within the following week. He said once the main doors are functional, the work will shift to the boardroom and the Auditor's entrance. He said the contractors are hoping to finish up early in January.
