RESOLUTIONS

The following resolution was presented and on motion approved.

RESOLUTION 2025-17

WHEREAS, Iowa Code section 459.304(3) sets out the procedure if a Board of Supervisors wishes to adopt a "construction evaluation resolution" relating to the construction of a confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR's decision regarding a specific application; and

WHEREAS, by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2025, and January 31, 2026, and submit an adopted recommendation regarding that application to the DNR; and

WHEREAS, the Board of Supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board's recommendation to the DNR may be based on the final score on the master matrix;

NOW, THEREFORE BE IT RESOLVED by the Clinton County Board of Supervisors that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code section 459.304(3).

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor David Troester said the Auditors office is moving ahead with preparation for the Senate District 35 election on January 28. The Board of Supervisors meeting next week will be held on January 21st at 9 a.m. and will be canvassing the Drainage Districts election.

Supervisor Srp said only additional meeting this week beyond budget sessions is attending the City Apple Improvement Plan meeting, since he is on that committee as the representative of the Board of Supervisors.

Supervisor Irwin said that he has a Ports of Eastern Iowa Authority meeting online.

Chairperson George said budgeting sessions start on January 14th at 1:00 p.m. She reminded everyone that the budget sessions are open to the public and she has an EMA commission meeting on January 15.

Sheriff Greenwalt said two active shooter, integrated response courses will be held in conjunction with local fire departments.

Mental Health Director Becky Eskildsen provided an update on the county guardianship program. As the region is sunsetting and will end on June 30. She said she is working with Mike Wolf, County Attorney, on transitioning those individuals affected by the change.

Veterans Affairs Director John Bray thanked Supervisor George and Supervisor Srp for their support for the event on December 27th. Bray said there we just over 40 in attendance and that resulted in 7 new appointments with applications for the new benefits. He said January 20th is Veterans Day on the Hill at the State Capitol in Des Moines. He will be attending to talk with our legislators and to highlight some of the duties of the County Veterans Service officer.

DISCUSSION WITH POSSIBLE ACTION

Evaluation Based Compensation: Human Resources Director Alexandria Weller said last year the County started the pilot for employee evaluations and also tied the compensation to that rating. Originally the intent was to reward high performers, however she doesn't think that we achieved that during the pilot. The Supervisors have decided to wait until budgeting season is over to decide on evaluation-based compensation going forward.

Linn County juvenal detention center contract: The six-month contract with Linn County is up for renewal and we renew it again for another six-months, it will be good through July 23rd and then the Scott County Juvenal Detention Center will be opening.

Resident Concerns over the Emergency Warning method: Judy Buntemeyer, County resident, expressed concern over the decision to decommission emergency sirens.

Combined Treasurer report: County Treasurer Dustin Johnson discussed the need for a regular Treasurer report to provide information to the Board of Supervisors. The Board expressed interest in the report.

Review of Supervisors' boards and commission assignments: Supervisor Srp said he shared the updated listing and if there are any changes needed, notify the contact that's listed. He reminded them to make sure that they know that they are now the supervisors appointed for that board/commission.

County Administration Building project update: Supervisor Irwin said that there was no meeting last Friday. The project is hopefully wrapped up by the end of January.
