WHEREAS, the Building Maintenance Manager, Mathew Lancaster, shall now be compensated at the hourly rate of \$31.63 effective immediately. Back pay discrepancy differences will be compensated from November 26, 2024.

WHEREAS, the Park Ranger, Colton Jones, shall now be compensated at the hourly rate of \$24.36, effective immediately. Back pay discrepancy differences will be compensated from October 15, 2024.
