RESOLUTION REIMBURSING CLINTON COUNTY'S MISCELLANEOUS GRANTS FUND FROM THE CLINTON COUNTY OPIOID SETTLEMENT FUNDS FOR PREVIOUS CONTRIBUTION MADE TO REDISCOVER RECOVERY COMMUNITY CENTER

WHEREAS, Clinton County joined class action lawsuits against various opioid manufacturers and vendors; and

WHEREAS, Clinton County has received a substantial amount of funds from the settlement of said lawsuits to be used for specific aspects of fighting back the effects of the opioid crisis in Clinton County; and

WHEREAS, on February 19, 2024, the Clinton County Board of Supervisors approved Resolution 2024-50 awarding the Rediscover Recovery Community Center with \$50,000 of Clinton County Opioid Settlement Funds to meet the obligation of a state grant requirement; and,

WHEREAS, on or about February 26, 2024, a payment in the amount of \$50,000 was issued to the Rediscover Recovery Community Center from Clinton County's Miscellaneous Grant fund as the funding was immediately available, and with the intention to reimburse the Miscellaneous Grant fund from Opioid Settlement fund when funding was available; and,

WHEREAS, due to an administrative oversight and unclear directives from the County's external auditors at the time the reimbursement did not occur in Fiscal Year 2024; and,

WHEREAS, the oversight was identified during the Clinton County's Workgroup meeting on April 23, 2025, and the County's external auditors are now in support of this reimbursement; and,

THEREFORE, BE IT RESOLVED that the Clinton County Board of Supervisors directs the County Auditor's office to initiate a claim in the amount of \$50,000 from the Opioid Settlement fund to reimburse the Clinton County Miscellaneous Grants fund for the previous contribution made to the Rediscover Recovery Community Center.
