County Sheriff's Office Update: County Sheriff's Office updated the Board on the use of part-time sworn deputies to augment the full-time sworn deputy workforce, the resources committed to fighting the war on drugs, and the relationship the Sheriff's department has with the federal prosecutors' office.

Secondary Road Project Update: Secondary Roads updated the Board on the roadside management work that has occurred in the county this year, including the stabilization and dust control of gravel roads, as well as the maintenance of paved roads.

County Conservation Update: Conservation updated the Board on an event happening at Rock Creek County Park. Fishing Has No Boundaries will take place on August 9th. On August 24, the Clinton County Conservation Board will host the Rock Creek Catfish Classic tournament. On October 4th, there will be a Halloween event at Eden Valley Campground and Rock Creek Campground on October 11th.
